- 7. All students who opt for available skill development/Training opportunities will be mapped to the CSR PARTNER Training Partners. Also Online follow up to take place with all participating employers on the final selection status.
- 8. Real-time Dashboard and reports on how many available, how many attended, how many interviewed, how many selected for each job profile shall be generated by **JEEVITAM**. The CSR PARTNER Training partners shall be given access to the dashboard of student leads who shall provide training to interested candidates on a chargeable basis from the Students/College Authorities.
- 9. All the Training & Certification will be provided by the CSR PARTNER Training Partners.
- 10. The Digital Campus Placement process will ensure complete privacy and data confidentiality.

### The responsibilities of VIVEKANANDA COLLEGE are of as follows-

- VIVEKANANDA COLLEGE shall assist JEEVITAM in organizing and conducting Digital College Placement Drives which shall be held once every month on a date and time mutually agreed upon by both the parties.
- 2. VIVEKANANDA COLLEGE shall aid JEEVITAM in this process by establishing a placement committee with required faculty and students heads and members. If a placement committee already exists in the college, the appropriate faculty and students shall be designated specifically for this purpose.
- 3. VIVEKANANDA COLLEGE shall provide JEEVITAM the name of its authorized College Placement Coordinator (Faculty) and a Campus Ambassador (Student) who will be responsible for Execution & coordination with JEEVITAM, CSR PARTNER, College Placement Committees & College Authorities.
- 4. The authorized college placement coordinator (Faculty) and The designated Campus Ambassador (Student) shall jointly organize and be responsible to hold not less than 2 meetings per month in order to decide the proposed date of the monthly digital campus placement drive and to develop, plan assign responsibilities and coordinate the specific activities agreed upon in the agreement.

Termination of this MOU shall not relieve either party of any obligation with respect to confidential information disclosed under this MOU prior to such termination.

#### **AUTHORITY**

Each of the parties warrants that it has all necessary rights, authority, and power to enter into this agreement and that it has obtained all necessary approvals to do so.

### LIMITATION OF LIABILITY

No rights or limitation of rights shall arise or be assumed between the Parties as a result of the terms of this Memorandum of Understanding.

### COSTS

This Memorandum of Understanding shall be governed by and construed in accordance with the laws of India & Indian Courts of Delhi having exclusive Jurisdiction with respect to technology usage infringements.

### **ASSIGNMENT**

Neither party to this Memorandum of Understanding may assign or transfer the responsibilities or agreement made herein without the prior written consent of the non assigning party, which approval shall not be unreasonably withheld.
