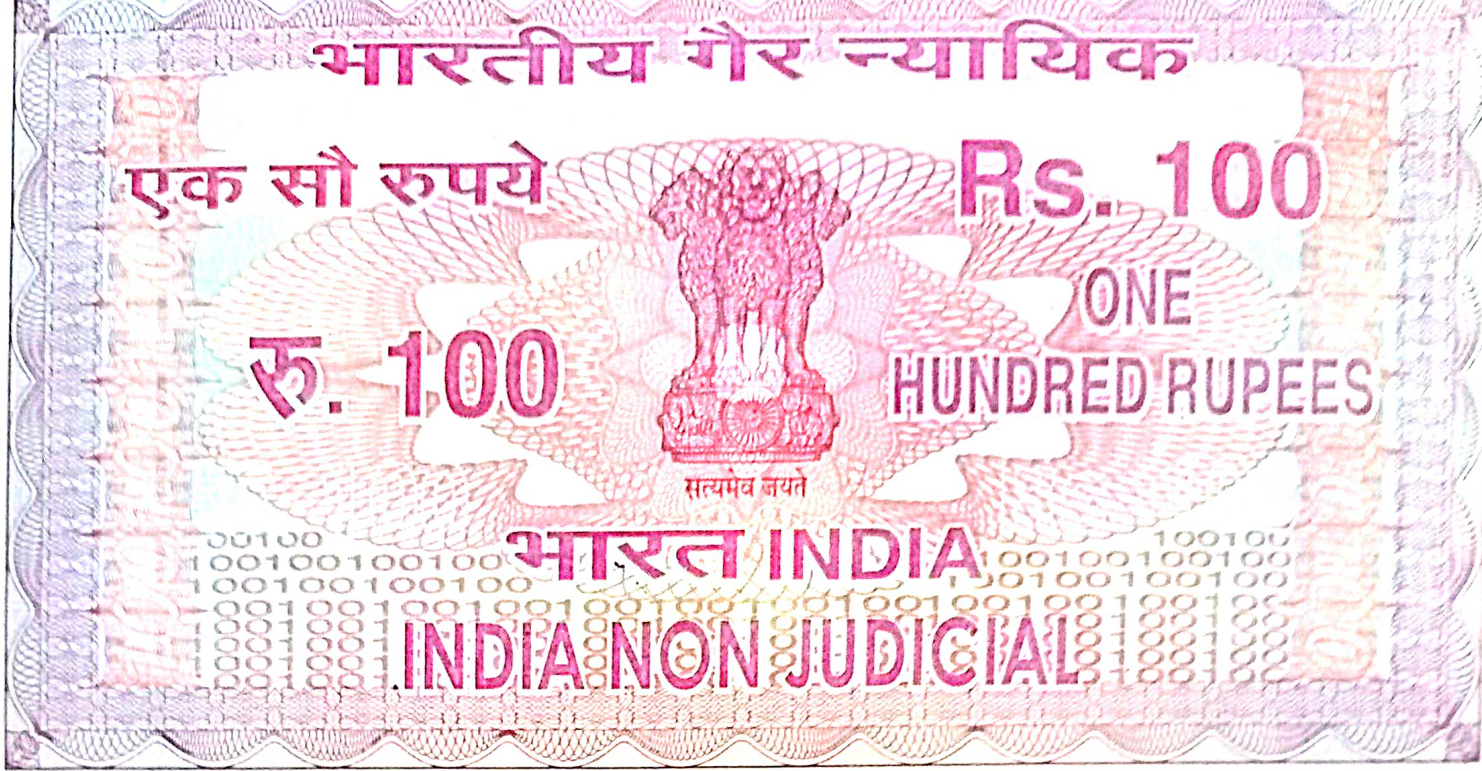

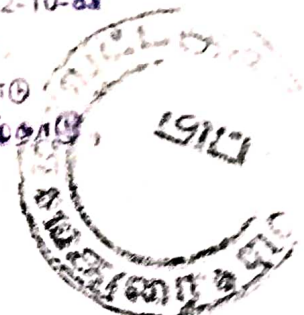

CONSIDERING the importance of science, technology, innovation and dissemination in their economic and social development;

RECOGNIZING that both Participants will disseminate and train the beneficiaries in Energy from Waste and carrying out research, and innovation activities in areas of common interest, and that joint participation in carrying out research activities on a reciprocal basis will be mutually beneficial;

SEEKING to facilitate further cooperation in research, innovation and dissemination that expands and strengthens the implementation of cooperative activities in areas of Energy from Waste by both the Participants and promote the application of the results of this cooperation for the benefit of society.

HAVE REACHED the following understanding:


I. OBJETIVES

1. To expand and deepen cooperation in science, technology, innovation and dissemination exchange of institutional experience, researchers and resources for the purpose of promoting sustainable growth, quality of life and equity.
2. To support and strengthen cooperative capacities in research and development (R&D) and to initiate and take up multi-sectoral, multi-organisational projects in the areas of science, technology, innovation, research and dissemination with support from Government of Tamilnadu, Government of India and their constituent Departments / Organisations in order to achieve transfer of technologies from lab to land and to solve location specific problems through science & technology interventions in the State of Tamilnadu.
3. To enrich the knowledge of people from different walks of life on the applications of Science & Technology in everyday life as well as the ill-effects of Superstitions.

III. AREAS OF COOPERATION

1. Major cooperative activities will be centered in the areas mentioned below:
 - a) Joint R&D projects in the priority areas mutually established by both Participants.
 - b) Coordination of visits by and exchanges of, scientist and technical experts, or academic specialists, including students and research scholars.
 - c) Joint organization of seminars, conferences, congresses, workshops and symposiums, training and support each other for these programmes.
 - d) Transfer of technologies from lab to land.
 - e) Science & Technology Interventions to solve location specific problems.
 - f) Dissemination of results and exchange of experience with respect to joint projects.
 - g) TNSCST will extend research guidance in the areas of Science, Engineering, Technology & Management and will give guidance to UG, PG and Ph.D. scholars of VC.
2. The Participants will promote the participation of scientific and technological R&D entities in the cooperative activities under the MoU.

IV. FINANCING


VII. LEGAL FRAMEWORK AND OBLIGATIONS
